

# **Alexion Charitable Foundation Health Equity Proposal Guide**

Congratulations! The Alexion Charitable Foundation invites you to apply for its new health equity grant program, which will help support innovative ways to address the inequities experienced throughout a rare disease patient's healthcare journey.

This document serves as a guide to help your organization present a high-quality and strategic grant proposal.

### Background

The Alexion Charitable Foundation (ACF) is dedicated to addressing health disparities among the rare disease community and ensuring that all underserved communities, including BIPOC families and those of lower socioeconomic status, have equitable pathways to the care, services and resources they need to live full lives. The Foundation's signature initiative, Rare Belonging®, partners with organizations supporting individuals, caregivers and families impacted by rare diseases.

Rare Belonging® has three giving pillars—Mental Health & Wellbeing, Barriers to Care and Health Literacy. Our *Barriers to Care* pillar is focused on strengthening the diagnostic journey and access to care by minimizing mobility, language, financial and knowledge barriers for people living with rare diseases. **An expanded aspect of this pillar will now include improving equitable access to diagnostics and health outcomes for people living with rare diseases.** 

Part of the broader rare disease community, undiagnosed patients can suffer years' long battles to find a diagnosis. Therefore, identifying innovative solutions is an area in which ACF is committed to being more deeply engaged.

## Barriers to Care Focus Area

ACF is poised to leverage Alexion's core health equity strategy to provide another avenue of giving in our Barriers to Care pillar. By committing to fund innovative solutions resulting in faster diagnoses, ACF will help address health equity by decreasing the diagnostic journey for more patients and increasing underserved patients' access to care.

Inaugural health equity partners will ground ACF's work for rare disease patients. Prospective partners will be able to effectively identify, reach and serve the needs of BIPOC, historically marginalized, and underserved communities in urban or rural settings by launching initiatives or projects focused on:

# **Accelerating Diagnosis**

- Enhancing data collection, analysis, and classifications for diverse and underserved populations with rare diseases.
- Improving the stratification of data diversity (i.e., causes, symptoms, health markers, etc.) to inform patient diagnosis and care.
- Leveraging innovative technology to advance rare disease research and decrease diagnosis timelines.
- Increasing utilization of rare disease health intelligence among healthcare and support services professionals.

#### **Improving Access to Care**

 Increasing physicians' and researchers' knowledge of diagnosis pathways for rare diseases.



- Enhancing evaluation protocols (testing, screening, etc.), interventions and tools to lessen the time to accurate diagnosis.
- Improving the quality of healthcare coordination with an emphasis on specialized and continuity of care from pre-diagnosis through disease management.
- Reducing structural and institutional barriers to diagnosis (bias, racism, social determinants of health, etc.).

Partnerships will have a 1-year grant term spanning from January to December 2025. Partners wishing to participate in subsequent open calls for proposals must meet all grant requirements, including submitting bi-annual updates to the Foundation via email and completing a year-end impact report in or before February 2026.

Please Note: Prior to applying, we encourage you to carefully review the Health Equity Program Guidelines (attached) and broader Rare Belonging® Grant Guidelines and Criteria. The application starts with a series of eligibility questions. Please ensure you are able to check "yes" to each of these questions. If the answer to any of these questions is "no," your organization is not eligible for a grant from the Alexion Charitable Foundation, and you should not proceed with the application process. Foundation staff will also be confirming alignment to these questions in its internal due diligence process.

### <u>Section 1: General Information</u>

Provide a project title, summary, start and end date. In the project summary, clearly outline how you propose to leverage innovative diagnostic tools to address barriers to care within your health system. The project summary should be viewed as the Foundation's initial point of reference in communicating a partnership.

Also in this section, please check "Barriers to Care" as the appropriate focus area for this program.

## Section 2: Budget

Provide budget information including the total request amount, overall project budget and annual organization budget. This information will be part of a <u>larger budget worksheet</u>, which outlines line-item details of expenditures for the proposed project. Please upload the filled-in budget worksheet to your application and ensure <u>each line-item</u> can be correlated to the project description provided in the Project Description section.



## Section 3: Project Description

**Need:** Please outline the specific diagnostic and access to care needs and barriers faced by the rare disease community (patient, caregiver, medical professionals, etc.) your organization currently serves or has the potential to serve. Provide evidence of the need, citing independent or third-party research, studies and/or organizational observations based on services rendered to the community. If able to extrapolate, please note what percentage of the total population served by your organization represents the rare disease community.

If you are not currently serving the rare disease community, please provide a case statement for how you believe your work experience could be transferrable and leveraged to address needs of the rare disease community.

**Project Description and Key Activities:** Use this section to succinctly articulate how your organization will address the diagnostic aspects of the Barriers to Care pillar identified in Section 1. Your response should allow the Alexion Charitable Foundation to clearly understand your organization's goals, planned activities, and internal/external resources that will be leveraged for effective implementation, including collaborations if applicable.

The Alexion Charitable Foundation seeks to partner with organizations that value creativity and innovation in their approach to program design, implementation, and service delivery. #### For Patients and Caregivers:

- A wholistic understanding of diagnostic options for patients with an unknown condition, series of symptoms that may or may not be prolonged, without explanation, or other experiences that may warrant diagnostic investigation.
- Recognition that pursuing a diagnosis leveraging innovative diagnostic interventions is a priority for the health system and providers.
- Increased opportunity for seeking diagnostic investigation, especially for underrepresented populations within the health system.

For Physicians (Medical Professionals) and Health Systems:

- Access to, and understanding of, rare disease symptoms and diagnostic tools needed.
- Stratification of data to identify healthcare disparities.
- Enhanced communication skills and practices to provide health information and diagnostic processes to patients and their families.
- Integration of evidence-based diagnostic practices and interventions for operational effectiveness.
- Improved health-related results, including diagnostic timeframes, for patients and caregivers.

#### For Community At Large:

- Knowledge and understanding of the importance of timely diagnosis and treatment among local community members.
- Improved health equity and quality of life for the rare disease community.
